

CA-AMNMCXXX	WHERE XXX = LENGTH IN FEET	CA-AMNMC010 (10 FEET)
CA-AMNMCNXX	WHERE NXX = LENGTH IN INCHES	CA-AMNMCN16 (16 INCHES)
CA-AMNMCMMXX	WHERE MXX = LENGTH IN METERS	CA-AMNMCMM07 (7 METERS)
CA-AMNMCXMX	WHERE XMX = LENGTH IN DECIMAL METERS	CA-AMNMC3M5 (3.5 METERS)
